This is to inform the Commission and the Exchange that Semirara Mining Corporation (the "Corporation") and its wholly-owned subsidiary, SEM-Calaca Power Corporation (SEM-Calaca) has concluded an agreement dated February 12, 2010 amending certain provisions of the Coal Supply Agreement (CSA) previously executed between the National Power Corporation (NPC) and the Corporation. The amendatory provisions were given retroactive effect from December 2, 2009 up to the expiration of the CSA or until June 30, 2010, and shall affect only the rights, liabilities and obligations of SEM-Calaca under the Asset Purchase Agreement (executed between SEM-Calaca and the Power Sector Assets and Liabilities Management Corporation), which as the new operator has the obligation to unconditionally and directly assume, be liable for and discharge all the rights, liabilities an obligations pertaining to the Purchased Assets, including the CSA with the Corporation.
