On June 21, 2011 Semirara Mining Corporation (SCC) informed the investing public of the Board's approval on SCC's additional investment in power generation of 600MW capacity in four (4) units of 150MW Circulating Fluidized Bed (CFB) Power Plants.

By way of update, please be informed that construction of the 2x150MW CFB (Phase 1) is in progress as scheduled under SCC's wholly-owned subsidiary Southwest Luzon Power Generation Corporation. For Phase 2, the Board in today's special meeting approved SCC's investment for a new configuration of 2x350MW using Pulverized Coal Technology instead of a 2x150 MW capacity as earlier disclosed. The initial plan is to implement this in phases and the timing of implementation is now being deliberated by management including the type of equipment to be used. Phase 2 will likewise be implemented by SCC's wholly-owned project company.
